

# टिप्पणी तथा आदेश

Hon'ble V.C.

The letter dated 01.05.2024, submitted jointly by the Principals of all the constituent colleges of University of Allahabad to your goodself (through Dean, C.D. , University of Allahabad) which is regarding admission in the constituent colleges of the University of Allahabad.

The Principals have referred to the Standard Operating Procedures (SOP) for the Central Universities issued by the UGC vide letter dated 04.10.2023 towards filling of vacant seats in UG classes and submitted that-

1. Ever since the inception of CUET, two years before, there has been an overall fall in new admissions and number of seats remained vacant in many Colleges, in several subjects , as students have either not appeared in CUET, nor generally aware of a new process of admission test.
2. There is an urgent need for re-drafting and introduction of a new Admission Rules for Admission in U.G. classes of The Constituent Colleges for admission(s) in all aculty of Arts, Commerce and Science for the Session 2024-25.
3. In SOP issued by UGC, it has been mentioned that, "It has come to the notice of UGC that a good number of seats are still lying vacant in some of the Central Universities even after three rounds of counselling. To keep the seats vacant for an entire academic year is not only a waste of resources but also results in denial of quality higher education to many students who aspire to pursue higher studies in Central Universities."
4. SOP has laid formulation for the filling up of vacant seats, as under :-
  - (a) That CUET score will remain the primary criteria for admitting students.
  - (b) The students who appeared in CUET but may or may not have applied to the respective University for the courses/programmes earlier may also be considered.
  - (c) The students who appeared in CUET may be considered irrespective of the domain subject papers in which they appeared.
  - (d) The University may relax the domain subject-specific criteria for admission to a particular course/programme.

(c) In case, seats still remain vacant even after exhausting the list of applicants who appeared in CUET, the Universities may take recourse to admit students on the basis of marks obtained in the qualifying examination.

5. As the final results of UP Board is already declared and CBSE results likely to be announced during mid-May, it shall be in the interest of the eligible students, The University and The Constituent Colleges, to urgently approve and announce 'The Scheme of U.G. Admissions for the Session 2024-25 for The Constituent Colleges of The University of Allahabad'.

In view of the above , they have also submitted a draft of "Scheme of Admission in U.G. classes (B.A., B.Sc. and B.Com) **IN THE CONSTITUENT COLLEGES FOR THE SESSION 2024-25** as detailed below, for kind consideration and approval-

### Round One of Admission (7-10 Days)

- Admitting CUET students in respective subjects.
- Submission of forms of CUET students in other subjects.
- Submission of Application of non- CUET students.

### Round Two (5-7 Days) :

- Admitting left-out CUET students of respective subjects.
- Admitting CUET students in other subjects.
- Submission of Application of non- CUET students.

### Round Three (5-7 Days) :

- Admitting left-out CUET students of respective subjects.
- Admitting left-out CUET students in other subjects.
- Submission of Application of non -CUET students.
- Admitting non- CUET students on the basis of Merit.

### Final Round (5-7 Days) :

- Admitting left-out CUET students of respective subjects.
- Admitting left-out CUET students in other subjects.
- Submission of Application of non-CUET students.
- Admitting non-CUET students on the basis of Merit.

Note :

- i. As soon as CUET results are declared, may be made available on Websites. The Colleges shall display also to attract, simultaneously the eligible students to seek admission in the University or any of the Constituent College(s) of his/her choice.
- ii. The University Registration Fee for CUET students (if any) shall be chargeable at the College-point at the time of admission. That will be transferred to the University along with the Final List.
- iii. Each Constituent College shall advertise in the newspaper(s) a detail Scheme and Schedule/programme of the Admission(s), week(s) before the first round admission commences.
- iv. Regular up-date of merit and date of admission shall be posted on College Website and also in the newspaper.
- v. Keeping 'Scheme of Admission U.G. classes (B.A. . B.Sc. and B.Com.1 in The Constituent Colleges for the Session 2024-25' as a common code of procedure, The Principal may be authorised to extend/ revise the duration(s) and round(s).
- vi. Effort shall be made to fill all the seats in various subjects for optimum utilization of available resources and providing Quality Higher Education.
- vii. As waiting time on and after declaration of CUET is narrowed down. The Colleges Shall be able to attract meritorious students from within the State and distant places.
- viii. The Academic session shall also commence normally.
